NORTH SHORE COMMUNITY COLLEGE

TUITION WAIVER FOR FULL TIME FIRE FIGHTERS LIVING IN MASSACHUSETTS

Under the provisions of the Massachusetts General Laws, Chapter 73, Section 20, amended by Chapter 550, certain fire fighters may be eligible for a tuition waiver while attending North Shore Community College.

To be eligible a person must:

- Be a matriculated student in the Fire Protection and Safety Technology Degree Program.
- Be a regular member of a fire department within the Commonwealth of Massachusetts as documented by a letter from a superior officer within their fire department. A sample copy of the wording of this letter is attached.
- State in writing their intention to continue their education in the Fire Science Administration Program at Salem State University. A sample copy of the wording of this letter is attached.
- Be a full time student, taking 12 or more credits, in the semester they are applying for the waiver. The only exception is a student in his/her last semester when they have less than 12 credits to finish their degree.
- Take only courses in the Fire Protection and Safety Technology Program of Study.

Students must apply for the tuition waiver each semester after they have registered for courses. They need not submit documentation of eligibility each semester unless there is a break between semesters.

There are no Tuition Waivers for Summer term courses.

The application and other documentation must be submitted to the Program Coordinator who will determine eligibility and issue the tuition waiver to eligible students.

The documentation that a student is a regular member of a fire department must be submitted on fire department letterhead and signed by an officer superior to the student.

For this reason, North Shore Community College issues a tuition waiver to full time fire fighters.
